 - Achievements
 - Scalable and innovative idea and/or business model
 - Market opportunities
 - Fundability
- The best entries will be admitted to the final, live pitch stage. They will be judged by a
 panel consisting of maximum five (5) experts, from organizations and businesses
 partnering "Disrupt Cyprus 2017". Names and profiles of judges will be announced via the
 competition webpage, at a later stage of the competition and no later than Fridat
